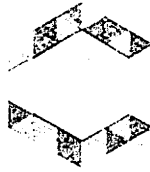

LOBBYIST COMPLAINT FORM

Any person that believes a professional lobbyist, redistricting commission lobbyist, or lobbying firm has violated the Colorado lobbyist laws or the Secretary of State's Rules Concerning Lobbyist Regulation, may file a lobbyist complaint. A complainant must specifically identify one or more respondents, a violation of Colorado lobbyist laws or rules, and allege sufficient facts to support a basis for the violations of law alleged in the complaint. (See 8 CCR 1505-8, Rule 5.1 & 5.3) Please be advised, complaints are public information and the Respondent will be provided a copy of this complaint.




On or about May 20, 2025 and continuing to the present, Shaman Botanicals, d/b/a American Shaman, d/b/a CBD American Shaman, d/b/a Dhamar Isomers, LLC, has published via email and online post an invitation to members of the public in Colorado to use links on the company's site to file with state representatives (variously to one or to all at their election) statements in opposition to Colorado SB 72. See the attached VIDEO recording of the web site, recorded on 5-23-2025, and see the attached screenshot of the web site, taken on 5-23-2025. In exchange for the submission of lobbying statements in opposition to Colorado SB-72, CBD American Shaman provides those who use the links certain of its products free of charge. In the instance of the filing of a statement in opposition to SB-72 via a link designated by CBD American Shaman for one state representative, CBD American Shaman gives the filer a 2-count pack of American Shaman 7-hydroxymitragynine free of charge. In the instance of the filing of a statement in opposition to SB-72 via a link designated by CBD American Shaman for all state representatives, CBD American Shaman gives the filer a 30 ml bottle of 7-hydroxymitragynine. The 2-count pack has a retail value of approximately \$10.00. The 30 ml bottle has a retail value of approximately \$60. CBD American Shaman is engaged in professional lobbying through this means. To the best of my knowledge and information, CBD American Shaman did not register as a lobbyist with the Department prior to and during the commencement of this lobbying campaign. The failure to register, disclose lobbying activities, and pay applicable fees constitutes a violation by CBD American Shaman of C.R.S. 24-6-302, 303, 304, and 305 along with 8 CCR 1505-8 and, in particular, this Department's Rules 2.1; 2.5; 2.6; 2.8; 3.1.; and 3.2. The complainant Global Kratom Coalition respectfully requests that the Secretary impose penalties on CBD American Shaman for engaging in this unlawful campaign; bar CBD American Shaman from registration as a lobbyist; refer the matter to the General Assembly; provide notice to the General Assembly that a substantial violation has occurred; apply to the district court for an order enjoining CBD American Shaman from continuing the unlawful campaign; and provide any other remedy that is appropriate to ensure that the law violations do not continue--all in accordance with Department Rule 4.6.
